

Health Guarantee/Agreement of Sale

To the best of our knowledge, every precaution has been taken to insure that your new pet is healthy. Buyer agrees to have the pup examined by a licensed veterinarian within 48 hours of the time pup is received to verify its health. If your pet is found to be unsound, please contact us immediately following the veterinary visit to inform us of any life threatening defect. A written-signed assessment by your veterinarian will be provided to us and if the seller's veterinarian agrees with the report, the puppy shall be replaced with another companion pup. Should the buyer decided to keep the pup, despite health issues, any/all costs for the dog's future care will be assumed by the buyer. Should a death occur, a necropsy will be needed to determine causation for the puppy to be replaced. The seller assumes no responsibility for this pet if it is not checked by your vet within the 48 hour timeline and results of vet check reported to seller by email or written notice. Failure to do so will void the warranty and health guarantee unless prior agreement was made as to the 48 hour time requirement for vet check.

The buyer and seller of the puppy agree that the buyer is responsible for any/all vet charges and necropsies after the date of purchase, including any incurred because of genetic/inherited defects. The buyer is also responsible for any shipping expenses of a replacement or returned puppy. Hypoglycemia, uneven bites, hernias, and luxating patellas (many times caused by injury/trauma) are not covered by this warranty. Please keep in mind, all of our pups are thoroughly examined, including patellas (pup does not leave here unless patellas are normal and tight), by a licensed veterinarian and shots and worming are up to date upon delivery. Also, remember, your pup will still need future boosters, rabies, etc. Dr. Lonnie Robichaux, DVM, is our veterinarian and his office phone number is 337-364-7624 should you want further information/references. Your pup is guaranteed against any life threatening/genetic defects for one year.

All of our dogs are purebred AKC registered from champion bloodlines. Full AKC registration (breeding rights) is seldom given without a contract to show/finish the dog. Buyer agrees to spay/neuter pet before one year of age. If puppy is not altered, with vet verification sent to seller, warranty is void. Spaying and neutering costs and any additional fees arising from these procedures, including undescended testicles, are the responsibility of the buyer.

Buyer agrees that dog will be raised as a house dog and provided with all necessary health care by a licensed veterinarian, including all remaining vaccinations, wormings, and rabies preventatives. Buyer also agrees that the puppy will not be taken into any public situations, i.e: Petsmart, groomer, dog park, etc, until puppy has received their 16 weeks checkup and all puppy vaccinations. Rabies is typically given around 4-6 months of age.

A non-refundable down payment of \$300.00 is required to reserve the pup of your choice. The balance is required 10 days prior to receiving/delivery of your pet. No other warranties or guarantee, expressed or implied, are made under this contract except those stated in this contract. This sales contract is non-transferable and should buyer relinquish ownership, contract is then null and void. Should events occur on the part of the buyer to delay agreed upon pickup time of pup, breeder reserves the right to charge boarding fees.
